



Kurukshetra through Educational Institute Shri Ram Private Industrial Training Institute **H. No. 862, Sector-5, UE, Kurukshetra** are owner of land bearing Hibba Nama 1987 dated 17.11.2016, Khewat no. 56, khasra nos. 10//25 land measuring 7K-11M in the revenue estate of village Sarai Sukhi, Tehsil Shahabad, District Kurukshetra.
